OSHA News - My Safe Summer Job Campaign

This week, OSHA kicked off the **#MySafeSummerJob** campaign to raise awareness about workplace safety among young workers during five weeks in April and May. OSHA, Wage & Hour Division, NIOSH and Alliance Program participants including AIHA, ASSP, BCSP, CareerSafe, CPWR, and NSC, have organized this campaign to reach out to young workers through social media as they look forward to beginning their summer jobs. Understanding the basics about workplace safety and health, and how to speak-up when something seems dangerous are foundational life skills, and fundamental for career-readiness. As young people enter the workplace, we must do all we can to prepare them to succeed. We have collaborated to gather resources and create a shared website with social media messaging and resources that can be used by all organizations to speak with one voice in this joint social media campaign.

Each of the five weeks will focus on one theme, and have daily accompanying messages that link to youth-focused organizations and can be shared:

- You Have Rights! (Week 1: 4/15 - 4/19/2019)
- Every Job has Hazards! (Week 2: 4/22 - 4/26/2019)

- Speak-Up! (Week 3: 4/29 - 5/3/2019)
- Injuries are Preventable! (Week 4: 5/6 - 5/10/2019)
- Safety Takes Teamwork - You Can Get Help! (Week 5: 5/13 - 5/17/2019)

Congress Introduces Bipartisan Voluntary Protection Programs Act

In a bipartisan effort to promote workplace safety, U.S. Senators and Members of the House of Representatives introduced identical bills to make the Voluntary Protection Programs (VPP) a permanent part of workplace safety in American industry. Four Members of the Senate House, Education, Labor and Pensions Committee introduced S. 904: Senators Michael Enzi (R-WY), Michael Bennet (D-CO), Johnny Isakson (R-GA) and Mike Braun (R-IN). In the House of Representatives, Labor and Education Committee Members David Roe (R-TN) and Elise Stefanik (R-NY) were joined by California Representatives Ro Khanna (D) and Mike Thompson (D) in introducing an identical bill, H.R. 1956, with Congressman Jamie Raskin (D-MD) cosponsoring.

A bipartisan mix of 70 Members of the House and Senate sponsored or cosponsored identical legislation in the 116th Congress. State legislatures in Indiana, Virginia, Arizona, Maryland and North Carolina have passed similar legislation in recent years. VPP recognizes workers, managers and companies that use best practices that go above and beyond the Occupational Safety and Health Administration's (OSHA) minimum safety requirements to enhance workplace safety and health. VPP worksites significantly reduce injuries and illnesses for approximately one million American workers in traditionally hazardous occupations at 2,200 worksites across the country, including 700 participating local unions. The U.S. Department of Labor (DOL) estimates that tens of millions of taxpayer dollars are saved annually through VPP and companies with VPP initiatives in place enjoy injury and illness rates that are more than 50 percent below industry averages.

"The VPP Act is critical because it ensures the permanence of a lifesaving program," said J.A. Rodriguez Jr., Chairman of the Voluntary Protection Programs Participants' Association (VPPPA). "VPPPA is committed to this legislation because it gives a million workers and their employers assurance that they are committing their time, training and resources to a program that will always be there for them."
