Want to Become A Special Government Employee?

The Special Government Employee (SGE) Program was established to allow industry employees to work alongside OSHA, particularly during VPP onsite evaluations. Not only does this innovative program benefit OSHA by supplementing its onsite evaluation teams, but it gives industry and government an opportunity to work together and share views and ideas. Qualified volunteers from VPP sites are eligible to participate in the SGE program. These volunteers must be approved by OSHA and funded by their companies to participate. After submitting an application and completing the required training, these volunteers are sworn in as SGEs and are approved to assist OSHA.

Get Involved in VPPPA - Join the National Board of Directors

2019 National Board of Directors Elections

In conjunction with the 2019 Safety+ Symposium, taking place August 27-30 in New Orleans, Louisiana, elections are scheduled to be held for VPPPA National Board of Directors' positions. This year there are several open positions:

- Vice Chairperson
- Secretary
- Director from a Site with a Collective Bargaining Agent
- Director from a DOE-VPP Site
- Director-at-Large (three positions available)

Each position has a term of two years, beginning at the end of the 2019 Safety+ Symposium and terminating at the 2021 Safety+ Symposium.

Submission Deadline: May 24, 2019
Eligible candidates will be notified by June 5, 2019.

Special Election

The VPPPA Special Election deadline has been extended. The VPPPA is seeking nominations for the open board position of Director from a Site Without a Collective Bargaining Agent. This position will be up for reelection in 2020. All interested parties should submit their Nominations Form by close of business on **Friday, May 24, 2019.**

U.S. Department of Labor Announces \$10.5 Million in Worker Safety and Health Training Grants

On May 3, OSHA announced the availability of \$10.5 million in Susan Harwood Training Grants for nonprofit organizations including community and faith-based organizations, employer associations, labor unions, joint labor/management associations, Indian tribes, and colleges and universities. The Harwood Training Grant [program](#) supports in-person, hands-on training for workers and employers in small businesses; industries with high injury, illness and fatality rates; and vulnerable workers, who are underserved, have limited English proficiency or are temporary workers. The grants will fund training and

education to help workers and employers identify and prevent workplace safety and health hazards.

Grants are available in three areas: Targeted Topic Training, Training and Educational Materials Development, and Capacity Building.

- Targeted Topic Training grants support educational programs that address identifying and preventing workplace hazards. These grants require applicants to conduct training on OSHA-designated workplace safety and health hazards.
- Training and Educational Materials Development grants support the development of quality classroom-ready training and educational materials that focus on identifying and preventing workplace hazards.
- Capacity Building grants support organizations in developing new capacity for conducting workplace safety and health training programs, and must provide training and education based on identified needs of a specific audience or a set of related topics.

Details on the grants and how to apply are available at [Grants.gov](https://www.grants.gov). Harwood applications must be submitted online no later than **11:59 p.m. EDT on Tuesday, July 2, 2019**.


