Hazard Communication

OSHA issues proposed rule to update hazard communication standard (HCS) to align with the seventh revision of the Globally Harmonized System of Classification and Labelling of Chemicals (GHS).

OSHA expects the HCS update will increase worker protections, and reduce the incidence of chemical-related occupational illnesses and injuries by further improving the information on the labels and Safety

Data Sheets for hazardous chemicals.

- OSHA has answers to questions about [reporting work-related exposures to COVID-19](#).
- Employers must post their Summary of Work-Related Injuries and Illnesses ([Form 300A](#)) from February 1 through April 30.
- Specific employers must [submit the required 2020 injury and illness data](#) by March 2.
