National Emphasis Program (NEP)

In response to President Biden's January 2021 [executive order](#), OSHA released a [National Emphasis Program](#) (NEP) on March 12, 2021, targeting industries where workers are at a high risk of contracting SARS-CoV-2, the cause of COVID-19.

This new NEP enhances OSHA's emphasis on COVID-19-related hazards by formalizing components of inspections in workplaces where employees have a high frequency of close contact exposures, and



where this hazard will be accomplished by a combination of inspection targeting, outreach and compliance assistance.
